PRIVACY STATEMENT FOR PROMOTIONAL ACTIVITIES

1. General

This privacy statement applies in addition to the general privacy policy, which regulates the processing of personal data for the purpose of the promotional activities (including competitions and promotions) of TOSS in Holland B.V. (hereinafter referred to as “**TOSS Group**” or “we”).

TOSS Group attaches great importance to the protection of your personal data and therefore wishes to inform you properly about how your personal data are processed. **TOSS Group** will treat and secure the personal information entrusted to it with the utmost care. By means of this privacy statement, we would like to explain how we process your personal data in connection with promotional activities.

2. What personal information is processed and why?

When you participate in a promotional activity - organised by **TOSS Group** - **TOSS Group** collects and processes your contact data (such as name, e-mail address, telephone number, Instagram username and possibly address data). This information is handled within the framework of a promotional activity, so that we can contact you when you have won one of the prizes.

You can participate by filling in your personal details in the manner indicated by **TOSS Group** for the promotional activity in question. By filling in this information, you grant **TOSS Group** permission to process the personal details you have filled in within the framework of the promotional activity in question.

3. Who has access to your personal details?

Your personal information will only be used to carry out a promotional activity. In principle, **TOSS Group** will not supply your information to third parties and will only supply it to third parties if this is necessary for the fulfilment of an agreement concluded with you or to comply with a legal obligation. We have concluded a processing agreement with organisations that process your details on our behalf in order to ensure the same level of security and confidentiality for your details. **TOSS Group** remains responsible for this processing.

4. What is the legal basis for processing your personal details?

In order to participate in a promotional activity, we ask you to provide some personal data. We use this data to process your participation on the basis of Article 6 Paragraph 1 (a) (consent) and/or (b) (contract) and/or (f) (legitimate interest) of the GDPR (Algemene verordening gegevensbescherming (AVG)). Our legitimate interest consists of establishing and verifying the legitimacy of your participation and compliance with the terms and conditions of the promotional activity and, if desired, to keep you informed of the status and/or results of the promotional activity.

5. How long do we keep your details?

The personal details we receive from you in this context will be kept for a maximum of three (3) months after the promotional activity has ended.

6. Your rights

You may withdraw your consent to the processing of your personal data at any time by sending an e-mail to legal@toss-group.com. In such a case, **TOSS Group** may have to cancel your participation and you may no longer be entitled to the prize of the promotional activity.

Furthermore, you have the right to access and/or change your personal details, the right to restrict the processing of your personal details, the right to transferability of your personal details and the right to be forgotten.
